Terms in the following document apply to all FlightSimExpo attendees.

In this document, “you” means you once you have registered for the event, “we”, “us” and “our” means or refers to FlightSimExpo Management Inc., “Hotel” means Tropicana Las Vegas – a DoubleTree by Hilton, and “Event” means FlightSimExpo 2020.

This document is current as of **December 10, 2019** and applies to registrations made on or after that date.

However, information such as an email address will never be shared with a third party without consent, except a third party who we have retained as described above.

FOOD AND BEVERAGE

ADMISSION TO FLIGHTSIMEXPO

We reserve the right to refuse any person admission to the Event, for any reason, in our sole discretion and to remove you if your behavior is deemed inappropriate and no refund of registration fees or attendance costs will be made.

If you cannot attend the Event, you can transfer your registration to another individual. Transfers can be completed before June 1, 2019 for a fee of \$25. Please note that any difference in registration fee or options will also apply.

REFUNDS

We understand that attendees' plans can change and aim to offer the most generous refund policy possible. However, we are charged additional processing and registration fees for each refund. Furthermore, our credit card processor only permits refunds within 90 days of the original transaction.

We will refund any canceled registration upon receipt of a written cancellation request within 88 days of the original transaction. Refunds will be available for the full value of the registration, less a \$25 administration fee, designed to cover the additional processing fees we incur.

Beyond the 88-day period, canceled registrations are not refundable. However, we will offer a credit equivalent to the value of the registration, less a \$25 administration fee. Credits are issued via email, are valid indefinitely, and may be used toward any online registration item, including Captains' Corner, T-shirts, and other purchases. However, credits are not available for on-site purchases.

POSTPONEMENT OR CANCELLATION OF THE EVENT

We have sole discretion to postpone or cancel the Event at any time. You agree that we will have no liability to you for any losses resulting from any delay or cancellation, including any travel or hotel costs. Further, we will not provide any refund of your registration fee.
